Noted: It is recommended by the officials' groups that there be 4 officials per 3 mats for tournaments

Wresting Cancellations:

- \*Any school that cancels an official, a match, or a tournament within 36 hours prior to the first scheduled match start of the event shall reimburse the affected official(s) 50% of the original contract.
- \*The only exceptions are cancellations that are related to weather conditions or other formal school closings.
- \*Officials who arrive at the site where a match has been cancelled unannounced to the official shall be reimbursed 50% of the contracted amount.

Additional matches:

- \*For a Varsity/JV Dual, the official shall receive an additional \$15 total if the number of (actual) matches, not including forfeits, refereed exceeds 35 counting varsity-JV-exhibition.

As a committee, we believe that officials are an important part of providing great athletic experiences to all participating student-athletes. We believe that we are addressing your association's concerns and would like to move forward with the provisions stated above.
